
# **Vision Zer**<sup>∞</sup>: share the vision – join the mission

Vision Zero, developed by the International Social Security Association (ISSA) in 2017, has become established worldwide as the most successful strategy for preventing occupational diseases and fatal and serious occupational accidents.

Its concept is based on the conviction that all occupational accidents and diseases are preventable. At the heart of the concept are the "7 Golden Rules" and the Vision Zero Guides. These promote a human-centric approach to work, a positive leadership culture, participation and sustainability as a facet of corporate culture. Besides its value to companies from an ethical perspective, Vision Zero leads to higher productivity, better employee retention and long-term economic success. It aims to establish safety, health and well-being in the workplace as an integral part of day-to-day work.

The Vision Zero Days at the A+A provide an opportunity for the community of Vision Zero ambassadors to be expanded and implementation of the rules deepened with the use of practical examples ranging from positive leadership to machine safety.






